RIGHTS ACQUISITION AGREEMENT

The following will confirm the agreement between Bertha Cecilia Navarro Solares in representation of Salamandra Producciones, S.A. de C.V. Representation, Warranties and Indemnities: Owner hereby represent a warrant that he has the full right and power to sign and perform this Agreement without the consent of any third party; and "Producers" hereby represents and warrants that: "Producers" have the full right and power to make and perform this Agreement without the consent of any third party. 5. <u>Miscellaneous</u>: This Agreement, which shall be governed by the laws of Mexico applicable to this agreement signed and to be wholly performed therein, expresses the entire understanding of parties hereto, replaces any and all former agreements negotiations, or understanding relating to the subject matter hereof, and shall not be except by written document signed by both parties hereto.

6. <u>Credit</u>: In accordance with the substantive credit rules of the applicable Mexican copyright law. Producers will grant Owner's Credit in the opening titles as "Epilogue inspired in "The value of money", from the book 'Pig Earth' written by John Berger."
