Dear Mr. Robards.

I am writing you in relation to the discussions you had with Paul Leduc about the possibilities of producing a film based on the novel "Under the Volcano" by Malcolm Lowry, screenplay written by Gabril García Marzquez, Paul Leduc and Richard Harwood, yourself cast in the role of the Consul, and Paul Leduc directing.

I represent the group which owns the motion picture and television rights of the novel, and is willing to participate in the project. I would like to give you the following ideas on this respect.

Three groups will be involved in the production of the film; Mexican,

Ourselves, who have invested aproximately 300,000 dls. in the adequisition of the rights, realization of the screenplay and promotion and preproduction, who are willing to participate with the major part of this investment, part to be recuperated before other participation from the first income from the explotation of the picture. The director Paul Leduc, who is willing to participate with his deferred salary.

Mexican producers, who will finance aproximately 50 % of the neccesary cash requirements.

French,

Which will participate with the deferred salaries of three actors, Laurel, Ivonne, Gregorio's widow, the director of photography, and a proportion of the cash required.

American,

Which will participate with the deferred salaries of two actors, the Consul and Hugh, and the remaining required cash.

We whall send you am up to date detailed production budget, however for the moment we estimate the total deferred participation and cash requirements (in thousands of dls.) as follows:

We wil require a guarantee assuring us that the principal photography of the film will commence no later than May 1980, we believe that the French and American groups should put

up this guarantee, which we estimate as 70,000 dls, amount which will be deducted from the total recuperation due us.

We would like to sign an agreement before the 3oth of April in order to be sure that the preparation of production for starting the film between November 1979 and February 1980 can be effected at the proper time.

As you have indicated, I will send a copy of this letter to Bob Montgomery, meanwhile I shall be waiting for your comments.
